#### **NEW BUSINESS:**

For new business the election results were discussed. The total votes for the election was 139. 103 residents came to the polls, and 36 were vote by mail. Commissioner Reahm added that this years' election did not see a significant climb at all, compared to the last previous elections. Moreover, Commissioner Reahm added that although the two polling stations were properly advertised, they did not contribute to increasing the results. Lastly, Commissioner Reahm concluded that the county does provide

free election equipment and services for the Fire District election, and would like to see the Commission take advantage of that in the future. Part-time paid staff hourly rates for the new hires was also discussed during new business. Chairman Powell asked if whether or not the salary guide approved for new hires had a set range or a set figure. It was concluded that there was a set range.

Lastly, the open MSR position was discussed under new business. Chairman Powell, Commissioner Sarkos, and Commissioner Reahm both met with a candidate from the Ewan Fire Department. That candidate was Brian Bartholomew Jr. Brian recently has returned from the Army and meets all the requirements for the MSR position. Moreover, Brian is already a certified Firefighter. Chairman Powell believes Brian would be a wonderful candidate, but will allow the board to make a final decision. Both Commissioner Reahm and Sarkos believed Brian would be a wonderful candidate. Commissioner Sarkos made a motion to hire Brian Bartholomew Jr. Commissioner Moore seconded. ROLL CALL VOTE: All Ayes. A memorializing resolution will be made for Brian's hire.

#### **UNFINISHED BUSINESS:**

An update on the hot water heater at Harmony was discussed. Chairman Powell was updated by Al Richer that the hot water heater has completely failed. Three bids to replace the hot water heater was discussed at last months meeting, Chairman Powell suggested for the board to go with the lowest bid. Larry made a motion to approve the next lowest bid for a hot water heater, Commissioner Sarkos seconded. ROLL CALL VOTE: All Ayes. An update on the new SCBA's was discussed during unfinished business. Chief Cardile stated that the SCBA's will be delivered to the Fire District on Friday the 18th. From there the SCBA's will be divided between both stations. 15 will go to Ewan and 15 will go to Harmony. District training will be conducted by Mid-Atlantic on the new SCBA's. Moreover, fit tested will be completed on top of two more weeks of training on the new SCBA's before they go into service by April's meeting. Lastly, an update on the new radios was discussed. Chief Cardile updated the board that the radios are in; it is just a matter of installing the radios in all the apparatus. Motorola has been having issues with techs showing up to work, so the installation process has been slow. Motorola should be sending out three techs to each station this week. The portable radios have also come in. They will be heading off to the County to be programmed. Lastly, the pagers have also come in and will be programmed this week.
